### 1—Fees, charges & discounts

*St Andrew's Grammar keeps fees as low as possible while maintaining the highest quality educational experience for all students. Fees cover costs that are an integral part of the curriculum, giving each student access to excellent learning resources and facilities.*

*Note: All amounts quoted in this document are in Australian dollars (AUD).*

#### Annual Fees

Annual School fees consist of Course Fees (Sect. 2) & Levies (sect. 3).

#### Registration Fee

A non-refundable registration fee of \$65 per application is payable on submission of your application for enrolment.

#### Enrolment Fee

A non-refundable, non-transferable enrolment fee of \$500 per student is payable on acceptance of offer for enrolment.

#### Discounts

If more than one discount is applicable concurrently (for example; scholarship, and advance payment discounts), these get applied on amounts after the other discount has been applied.

#### Sibling Discounts

Sibling Discounts are applied to tuition fees only and are offered as follows:

- Second Sibling attending concurrently: 20%
- Third sibling attending concurrently: 40%
- Fourth Sibling attending concurrently: 65%

## 3—Levies

### Resource Levy

The Resource Levy assists with the funding of camps, retreats, transport, excursions, incursions, and other compulsory activities.

### Technology Levy

The Technology Levy assists with the funding of IT support, laptop computers (Y1 – 12), software licenses and internet usage.

### Capital Levy

The Capital Levy helps fund programmes to further enhance the school's facilities. This remains at \$250 per student.

## 6—Late payments

**A late payment fee of AU\$150 may be charged on accounts not paid by the due date.** Direct Debits returned unpaid may also incur the late payment fee. In addition, discounts may be forfeited for accounts not settled by the due date. If the tuition fees remain outstanding at the end of a term, the Principal reserves the right to suspend or terminate your child's enrolment.
